Business:

1. Stoughton Utilities Strategic Alignment and Position Description Updates

Swadley and Weiss highlighted that the position updates outlined in the strategic alignment plan have been implemented, noting that there has been one internal promotion, two new employees that started at the utility today, and two new employees planned to start in the upcoming weeks. Discussion followed.

<u>Stoughton Utilities Proposed 2023 Budget and Five Year (2023 – 2027) Capital Improvement Projects (CIP) Plan:</u> Stoughton Utilities staff presented and discussed the proposed 2023 Stoughton Utilities budget. Discussion followed. Stoughton Utilities staff presented and discussed the proposed five-year (2023-2027) Capital Improvement Projects (CIP) Plan. Discussion followed.

Motion by Kallas, the motion seconded by Hirsch, to approve the Stoughton Utilities five-year (2023-2027) Capital Improvement Projects (CIP) Plan and the Stoughton Utilities 2023 budget appropriations in the sum of \$20,935,837, and recommend approval to the Stoughton Common Council at their November 15, 2022 meeting. The motion carried unanimously 5 to 0.

<u>Stoughton Utilities Position Description Updates: Finance Division:</u> Stoughton Utilities staff presented and discussed proposed position description updates for the existing Payroll & Accountant II and the Utilities Finance Manager positions, noting there will be a title change of Accounting Specialist for the former and no title change for the latter. The position description updates were made to reflect the positions' current job duties and responsibilities. Staff presented proposed final and redlined versions of the updated job descriptions.

Motion by Tikalsky, the motion seconded by Hirsch, to approve the proposed Stoughton Utilities Finance Manager and Accounting Specialist position descriptions and recommend approval to the Stoughton Personnel Committee and Stoughton Common Council, with such changes as are acceptable to and recommended by the City of Stoughton Director of Human Resources & Risk Management. The motion carried unanimously

Wastewater Treatment Facility and Sanitary Sewer Collection System 2021 Compliance Maintenance Annual Report (CMAR): DNR Response: Stoughton Utilities staff presented an update to our annual CMAR filing, which was approved by the Utilities Committee and Common Council in June. The Wisconsin Department of Natural Resources (DNR) has received and approved our filing, providing favorable comments, and no further action is needed until the 2022 CMAR filing to occur in June 2023. Discussion followed.

2021 Public Power Week Community Outreach Event Summary: Stoughton Utilities staff presented and discussed our recent Public Power Week scavenger hunt customer outreach program. On Monday, Wednesday, and Friday during the week, SU published clues directing participants to a secret Stoughton location where customers could photograph themselves next to a SU face cutout board and submit the photos to SU. All scavenger hunt locations were community parks. On Tuesday and Thursday, we offered a prompt for customers to provide responses to SU regarding several topics. Staff provided the committee with the daily clues and their answers, and a sampling of participant photos and customer feedback. Discussion followed.

<u>Utilities Committee Future Agenda Items:</u> Stoughton Utilities staff informed the committee that there are no agenda items planned for upcoming meetings, noting that the upcoming November and December meetings may be cancelled if no agenda items arise.

Financial Summary September 2022 YTD

Overall Summary:

September YTD 2022 operating income was \$1,064,346, down \$291,223 from 2021. Electric and wastewater both saw decreases in income of \$115,708 and \$193,015 respectively, while water saw an increase of \$17,501.

Electric Summary:

September 2022 YTD operating revenues were \$12,878,135, 8.5%, higher than 2021. Revenues are higher, with lower sales, due to a positive PCAC. This increase in PCAC is to offset rising purchase power costs. Kilowatt-hour sales were down 1.96% from September 2021 YTD, and down 17.5% from August 2022. Purchase power costs were up \$962,242, or 11.1%, from the same time last year. Non-power operating expenses were up \$162,083 from the prior year due to an increase in overhead and underground line maintenance.

The September 2022 rate of return was 3.75%, compared to 4.51% for September YTD 2021. Unrestricted cash balances are \$4.7 million (3.3 months of sales).

Water Summary:

September 2022 YTD operating revenues were up \$95,248, or 5.2%, from 2021. Total gallons sold were down 11.1% from September 2021 YTD, and down 10.5% from August 2022. The increase in revenue is due to the rate increase effective March 2022.

Operating expenses were up \$77,747, or 5.3%, compared to the same time last year.

The September 2022 rate of return was 3.51%, compared to 3.25% for YTD 2021. Unrestricted cash balances are \$1,494,834 (7.3 months of sales).

Wastewater Summary:

September 2022 YTD operating revenues were down \$58,618, or -3.5%, from the same time in 2021. Total gallons sold were down 11.7% from September 2021 YTD, and down 5.0% from August 2022. The decrease in revenues was due to lower sales.

Operating expenses were up \$134,397, or 10.1%, from 2021. The increase is due to plant maintenance, sludge hauling and depreciation.

Unrestricted cash balances were \$861,202 (5.0 months of sales).







Each year, Stoughton Utilities holds an annual Public Power Week event that highlights the benefits that "public power" brings to the utility, its customers, and the City of Stoughton.

Dear Ms. Weiss:

I wanted to reach out and personally thank you for recently offering and sending your skilled line crews and equipment in response to New Smyrna Beach Utilities (NSBU) request for mutual aid after Hurricane Ian.

While Florida is not certainly a stranger to Hurricanes, the City of New Smyrna Beach was infamously impacted by the combination of; 96 mph winds and over 21 inches of rain in just over 24 hours- a 1 in 500-year flooding event. For context, the State of Florida receives a little over 50 inches of rain annually, and we received approximately 40% of our annual local rainfall in just over 24 hours. The NSBU service territory also includes some surrounding areas of Volusia County. For additional context, as of 10-21-22 the Volusia County Property Appraiser assessed Hurricane Ian had inflicted more than \$325 million in damage to nearly 7,000 homes in the County.

At the peak of the Hurricane, 91% of NSBU's 30,000 customers were out of power. However, thanks to the hard work of the crews supporting the overall effort, the majority of our priority feeders and other critical facilities were restored within the first 24 hours after the hurricane winds left our territory. Next, we were able to restore power to 97% of all of those affected customers within 72 hours.

The phenomenal success of this restoration effort ultimately realized for our community was made possible with the assistance of mutual aid crew resources. The multiplying effect of the Public Power crews allowed us to expand the number of our day-to-day internal crew resources by approximately tenfold. The Public Power network of mutual aid partners coordinated for us by Florida Municipal Electric Association and American Public Power Association is greatly appreciated.

Thank you again for being our partner in restoration of our community after Hurricane Ian.



Subject: Presentation: Stoughton Water Quality – 2022 Lead and Copper Sampling Results

In accordance with regulations set by the Wisconsin Department of Natural Resources (DNR), Stoughton Utilities collects water samples homes each year and tests those samples to determine the amount of lead and copper that is present in those homes' drinking water. These samples are taken from inside the homes at a faucet that provides drinking water.

Although no level of lead is considered completely safe, the Environmental Protection Agency (EPA) and DNR set a level of 0.015 mg/L (15 parts per billion).

In 2019, this water quality monitoring at 30 homes found elevated levels of lead that exceeded the action level in six of the 30 homes sampled. As a result, the Stoughton Municipal Water System exceeded the 90th percentile level, meaning that more than 10% of the samples tested contained a level of lead greater than 15 parts per billion (ppb) or 0.015 mg/L.

We are proud to announce that our 2022 sampling and water quality monitoring did not find elevated levels of lead in any of the homes sampled. 60 homes were sampled in 2022. Five of the homes sampled had no detect, 52 had lead levels between 0 and 5 parts per billion (ppb) or 0.000 - 0.005 mg/L, two had lead levels between 5 and 10 ppb or 0.005 - 0.010 mg/L, and one home had lead levels between 10 ppb and 15 ppb or 0.010 - 0.015 mg/L. No samples were above the 15 ppb or 0.015 mg/L 2019 exceedance level.

History:

As a result of the 2019 sampling results, Stoughton initiated the following actions:

- Engaged in additional community education and outreach,
- Conducted additional sampling,
- Engaged the Utilities Committee and Stoughton City Council to enact an ordinance requiring property owners to replace lead service lines present on the private side of the water system,
- Engaged the Utilities Committee and Stoughton City Council to formalize a lead service line replacement program and a mechanism for providing funding assistance to property owners, and

- Provided a water filtration pitcher at no cost to homes served by lead service lines where residents
 may be at a higher risk of the health impacts from lead, such as homes with young children or
 expectant mothers, and
- Collaborated with the DNR to achieve the requirements required of the utility following exceedance of the action level.

In 2021, Stoughton Utilities completed a project to replace all known lead service lines in the City of Stoughton. As part of the project, lead service lines were replaced at 703 parcels, including the replacement of 340 publicly owned and 653 privately owned lead service lines. Following the completion of this project, there are now zero known lead service lines remaining in the City of Stoughton.

Stoughton Utilities commemorated the project completion with a ceremonial removal of the last lead service line on October 21, 2021, with representatives from the utility, the project contractor, the Wisconsin Department of Natural Resources, engineering consultants, and the City of Stoughton in attendance, as well as media organizations and members of the public.

Ongoing Efforts

Since the removal of the last known lead service line, Stoughton Utilities has continued our public education and outreach programs, with topics consisting of how residents can flush their internal plumbing systems and clean their faucet aerators to help ensure no lead particulates remain, and encouraging property owners to replace older faucet and other plumbing fixtures that may contain lead materials.

Education and outreach efforts include statements on our monthly billing statements, press releases, direct mailings to key stakeholders including health facilities and day care centers, and presentations to stakeholders including the Stoughton Utilities Committee and Common council. Periodic reporting of our education and outreach efforts is submitted to the Wisconsin Department of Natural Resources (WDNR) in compliance with the requirements established following our 2019 exceedance.

Stoughton Utilities will conduct another round of sampling at 60 homes in 2023. If the results are similar to those recently found in the 2022 sampling, WDNR mandated education and outreach efforts will be reduced, and future sampling will occur at a reduced number of homes.






Lead & Copper Rule

- 1991, EPA published a regulation to control lead and copper in drinking water the Lead and Copper Rule (LCR)
 - Purpose: Protect public health by minimizing lead (Pb) and copper (Cu) levels in drinking water, primarily by reducing water corrosivity. Pb and Cu enter drinking water mainly from corrosion of Pb and Cu containing plumbing materials.
 - ► Establishes action level of <u>0.015 mg/L for Pb</u> and <u>1.3 mg/L for Cu</u> based on 90th percentile level of tap water samples.
 - ► An action level exceedance is not a violation but can trigger other requirements that include water quality parameter monitoring, corrosion control treatment, source water monitoring/treatment, public education, and lead service line replacement.
 - ▶ New Regulation additional requirements if 90th percentile level of tap samples
 - ▶ 0.010 mg/L for Pb
 - ▶ Inventory requirements are the focus of December 2021 rule revisions.




Sampling - Water Quality to the Tap

- ► Lead & Copper Sampling
 - Sampled at the tap (faucet)
 - Cold water
 - Unfiltered
 - No water use for at least 6 hours (stagnation)
 - ► Create contact between water and lead for a period of time

 - Greatest potential to have significant lead levels
